## (i) Budget Work Session FY 2023-2024

General Manager Janet Guthrie presented another version of the draft budget that had the certified tax roll at the same rate as last year as well as the no new revenue tax rate, voter approval tax rate and the deminimus tax rate. The board worked through several items of discussion. A brief discussion was held regarding the various line items and a discussion was held regarding the option of having a self-regulated Health Savings Account with Happy State Bank or hiring Fidelity to establish a managed Health Savings Account or other Savings Account as allowed by law.
