I, the undersigned applicant, agree and certify that:

- (1) the applicant has the authority to drill and operate a well at the described location for the proposed beneficial use;
- (2) this well will be drilled within ten (10) yards of the location specified and not elsewhere;
- (3) I will furnish the District with the completed Driller's Log, any electric log, and the well completion report within sixty (60) days of the completion of the this well;
- (4) in using the well at issue in this application, I will comply with all terms and conditions contained in the associated production permit, avoid waste, achieve water conservation, and use reasonable diligence to protect groundwater quality;
- (5) I understand that the District's rules and certified groundwater management plan may be amended from time to time, and the District has the right to manage production of groundwater from the aquifer within the District's boundaries according to current and future rules
- (6) I understand the District may enter the land upon which this well is to be located;
- (7) I will follow State and District well plugging guidelines at the time of well closure;
- (8) This well must be completed in accordance with Texas Department of Licensing and Registration Rule 76.1000 Technical Requirements- Locations and Standards of Completion for wells, and;
- (9) the information provided herein is, to the best of my knowledge, true and correct, and that it shall be considered to be fraud upon the District to willfully give erroneous information in this application.
